#### What about Cookies?

Cookies are most often small text files that websites may put on your computer whilst you are browsing. Cookies are used for many different purposes. For example, they can:

- help search engines remember that you want your search results in English;
- help a website remember your preferences so that you don't need to customise it every time;
- help a website to deliver a better service by showing you the content most relevant to you;
- identify and resolve errors so that the site is improved for everybody;
- analyse how well a website is performing.

The most common function of cookies is to remember bits of information that help make browsing the web easier and more hassle-free for you.

## How we get the personal information and why we have it

Most of the personal information we process is provided to us directly by you for one of the following reasons:

- Working with your child(ren) in a school or other organisation
- Providing private tuition

We will not share information without gaining your permission first.

Under the General Data Protection Regulation (GDPR), the lawful bases we rely on for processing this information are:

- (a) Your consent. You are able to remove your consent at any time. You can do this by contacting Miss Sam Stocken, Company Director
- (b) We have a contractual obligation
- (c) We have a legal obligation

# How we store your personal information

Your information is securely stored on a passcode protected laptop.

We will keep reports for 6 months from when they were written or 6 months after the last communication with the setting or family. We will then dispose of your information and written reports by deleting it from the laptop.

## **Your data protection rights:**

Under data protection law, you have rights including:

Your right of access - You have the right to ask us for copies of your personal information.

**Your right to rectification** - You have the right to ask us to rectify personal information you think is inaccurate. You also have the right to ask us to complete information you think is incomplete.

Your right to erasure - You have the right to ask us to erase your personal information in certain circumstances.

**Your right to restriction of processing** - You have the right to ask us to restrict the processing of your personal information in certain circumstances.

**Your right to object to processing** - You have the the right to object to the processing of your personal information in certain circumstances.

**Your right to data portability** - You have the right to ask that we transfer the personal information you gave us to another organisation, or to you, in certain circumstances.
